

Liquipel Aquaguard Limited Warranty – Water Protection Plan (the “WPP Limited Warranty”)

Subject to the limitations of this WPP Limited Warranty, Liquipel warrants that the Liquipel (Aquaguard) device protection product (“Product”) will be free of defects in material or workmanship for a period not to exceed one (1) year from the original date of purchase of the Product (the “Warranty Period”) by the original purchaser (“You”, “Your”). The Warranty Period shall be specified in or on Your original Product packaging or purchase receipt. Liquipel does not warrant any electronic mobile device or accessory manufactured by any entity other than Liquipel.

WARRANTY REGISTRATION REQUIRED: Please note, You must register Your WPP Limited Warranty at www.liquipel.com/registration within thirty (30) days of purchase. Failure to do so will void this WPP Limited Warranty. This WPP Limited Warranty is non-transferable and only applies to the original purchaser.

ELIGIBILITY REQUIREMENTS: To be eligible for this WPP Limited Warranty, You must satisfy all of the below listed criteria:

1. You must be a resident of the United States;
2. You must have purchased Your Product from within the United States from a retailer with a physical address in the United States or from the Liquipel website www.Liquipel.com;
3. You must have a successfully registered the Product on the Liquipel website www.liquipel.com/register within thirty (30) days of purchase as described above;
4. The device for registration under the WPP Limited Warranty must be activated and undamaged at time of registration.

PRODUCT DEFECT: If the Product has a material or workmanship defect when received or becomes defective and a valid claim is received within the Warranty Period, Liquipel will replace the Product with a new or refurbished product of like kind or similar quality or features. For purposes of this WPP Limited Warranty, “refurbished” means a product that has been substantially returned to its original specifications. If You experience a Product defect, You must file Your claim online at www.Liquipel.com within thirty (30) days of the purported failure. Liquipel reserves the right to charge a shipping and handling fee (not to exceed \$15) in connection with the fulfillment of any valid claims.

LIQUID DAMAGE: If the Product is properly installed on Your device and the Guidelines for Appropriate Use (“GAU”) are followed, Liquipel guarantees that the Product will perform substantially in accordance to the specifications furnished by Liquipel. Should Your device experience liquid damage due to a Product material or workmanship defect and a valid claim is received within the Warranty Period, Liquipel will replace Your device, subject to a USD \$29.99 deductible, with a new or refurbished device of like kind or similar quality and features. This WPP Limited Warranty does not cover negligent, fraudulent and/or intentional damage. This WPP Limited Warranty does not cover reimbursement for the purchase of a replacement device. Liquipel must be notified within thirty (30) days of the purported failure by submitting a claim to our administrator, and Your device and Product must be made available for inspection and verification of defects by our administrator.

HOW TO FILE A LIQUID DAMAGE CLAIM: Liquipel must be notified within thirty (30) days of the purported failure by calling our Toll Free number (800) 549-1725, and the device and Product must be made available for inspection and verification of defects by our administrator. You must have Your

Product serial number to make a claim. Your WPP Limited Warranty serial number is a unique number that appears in the packaging of the Aquaguard Product. When sending in Your Product and device, Your device must have the Product installed when the unit is sent for claim assessment. A customer service representative will provide information on Your claim options, shipment, and claim settlement. This WPP Limited Warranty shall expire upon replacement of Your damaged device.
